# Children's Intensive In-home Behavioral Support

### **Overview**

The Children's Intensive In-home Behavioral Support waiver is one of our five federal Home and Community-Based Services waivers.

The CIIBS waiver supports children at high risk of out-of-home placement due to challenging behaviors and helps them live successfully at home with their families. The goals are to improve support to families and strengthen their child's success in the family home and community. Individualized support planning is collaborative and team based. Each child and family team includes family members, friends, service providers, school staff and others important in the child and family's life. Planning builds on strengths and works toward outcomes driven by the family.

# **Budget**

The capacity for the CIIBS waiver is up to 200 individuals. In state FY23, 167 individuals were served on the CIIBS waiver at an average cost of \$2,065 per month. Waivers are limited to the average cost of an Intermediate Care Facility for Individuals with Intellectual Disabilities for any combination of services necessary to meet the assessed client need. DDA cannot deny services to people on the waiver due to lack of funding, so waiver costs are carefully monitored.



# **Eligibility**

DDA clients who and are age 8 or older and under the age of 18 for initial enrollment and under age 21 for continued enrollment and:

- Meet Social Security Disability criteria.
- Meet Institutional Level of Care criteria.
- Meet the income and resource standards for Apple Health of Washington. (Based on client's income and resources.)
- Are a U.S. citizen or federally qualified legal resident.
- Have a DDA Assessment and Person- Centered Service Plan that describe how the child's health, safety and habilitation needs will be met in the community.
- Have agreed to accept home and communitybased services and the CIIBS service delivery model as an alternative to institutional services.
- Have been assessed at high or severe risk of out-of-home placement due to challenging behaviors prior to enrollment in the program.
- · Live with their family.
