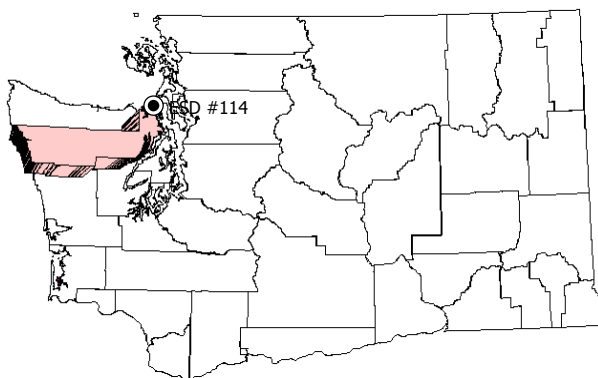
### Abstract

Education Service District #114 has worked collaboratively with the Brinnon School District, Quilcene School District, Port Townsend School District, Chimacum School District, Mountain View Elementary, Blue Heron Middle School in Port Townsend, Student Assistance Programs, Jefferson County Health & Human Services, Jefferson County Community Network, Jefferson County Alcohol and Drug Abuse Services Advisory Board, and the Jefferson County Prosecuting Attorney. Jefferson County is presently one of the fastest growing counties in Washington and has a large unincorporated rural population in the east county area.

The prevention projects and activities will include the Take Time Program, the Strengthening Families Program, and the Functional Family Program. These prevention programs focus on students and their families with components that include family skills training, parent training, children's skills training, and conflict management.
