 (a) A "qualified alien" as defined in WAC 388-424-0001 who is in-
- (a) A "qualified alien" as defined in WAC 388-424-0001 who is ineligible for temporary assistance to needy families (TANF) due to the five-year bar as described in WAC $388-424-0006((\frac{3}{3}))$;
- (b) A "nonqualified alien" who meets the Washington state residency requirements ((as listed)) in WAC 388-468-0005, including a noncitizen American Indian who does not meet the criteria in WAC 388-424-0001; or
- (c) A "survivor of certain crimes" as defined in WAC $388-424-0001((\frac{(4)}{1}))$.
- (2) To receive aged, blind, or disabled (ABD) cash or pregnant women assistance (PWA) benefits, you must be:
 - (a) A "U.S. citizen" as defined in WAC 388-424-0001;
 - (b) A "U.S. national" as defined in WAC 388-424-0001;
 - (c) An American Indian born outside the U.S.;
- (d) A "qualified alien" ((or similarly defined lawful immigrant such as victim of trafficking)) as defined in WAC 388-424-0001; or
- (e) A "nonqualified alien" as defined ((described)) in WAC 388-424-0001 who((÷)) , U.S. Immigration and Customs Enforcement is not taking steps to enforce their departure; or
- (((i) Has verified their intent to stay in the United States indefinitely; and
- (ii) The United States Immigration and Customs Enforcement is not taking steps to enforce their departure.)
